Are Your Live Fire Training Events Dangerous?

Whether you are conducting live-fire training events with "in-house" instructors, using a training provider, or attending a state fire academy or institution, it is incumbent upon all leadership and instructors to ensure that the training provided to their emergency responders and students is safe and effective.

This workshop will cover the importance of ensuring live-fire training events are compliant with the latest NFPA industry standards, as well as the OSHA regulation on fire brigades for those teaching industrial students. Additional topics include: written pre-burn plans, pre-fire safety walk-throughs, limitation of live victims, positional duties for live-fire events, accountability, PPE inspections, lead instructor requirements, and instructor to student ratios.
