"LIGHTENING THE LOAD" FOR LOCAL FIRE DEPARTMENTS

As an industry or company, I want to ask you a thought-provoking question: How can your company help your local fire department?

To start with, do you have a dedicated industrial or emergency response team (ERT)? Do you have a team that focuses on the importance of fire prevention and safety?

Even though local fire departments invest in their firefighters by spending time and effort training, are you expecting your local fire department to tackle a large (or small) industrial incident?

In the May 2022 issue of *Fire Engineering*, Dan King wrote an article entitled "<u>The Importance of Industrial Firefighters</u>." I encourage you

King is correct when he states that if you invest the same time and effort into your industry fire training, you are actually helping your local fire department. He calls it, "lightening the load on local municipal or volunteer fire departments."

to take a few minutes and click on the hyperlink to read it. I also want to share a few thoughts with you.

I'd like to highlight a bit of his informative article.

First, he touches on the long-lasting physical and financial impact of industrial fire damage:

"Industrial fire can wreak havoc and cause a devastating degree of damage. They put everyone within the building and surrounding it at risk of death or injury from inhalation, burns, or building collapse. They also put those same people at risk of losing their jobs and livelihoods, given that industrial fires often result in the building's temporary or even permanent closure. Moreover, when industrial fires occur, they can shut down surrounding businesses, interstates, schools and in some cases, air travel."

King also shares with readers the benefits of having an ERT:

"Organizations with a dedicated (i.e., full-time) industrial or emergency response team (ERT) have a considerable advantage over organizations that do not. Most notably, they tend to report higher industrial fire prevention rates and shorter incident response times. Maintaining a state of emergency readiness in an environment where high hazards are located takes focus and attention. Dedicated industrial firefighters provide both."

Lastly, he encourages every company with high hazards to consider establishing a dedicated industrial fire department. When doing so, he says they "should partner with the local fire department and spread awareness throughout the community, emphasizing the extra layer of safety provided." This includes industry-related fire safety personnel educating other staff members as well as the community.

If your company and local fire department want to arrange a meeting to discuss future training needs and ideas, especially regarding how to "lighten the load," I am happy to meet with everyone involved.



SCFA Dormitory

We recently completed a multi-million dollar renovation on our dormitory. The top-to-bottom renovation includes new paved parking areas, a hotel-like reception area, new furnishings, and an expanded weight room/gym area.
