



Curriculum Updates: Driver/Operator Series Programs

As previously communicated (<u>click here to view</u>), effective September 1, 2025, the South Carolina Fire Academy will begin offering updated Driver/Operator series programs. This update aligns course content with the 2024 edition of NFPA 1010. The curriculum will transition from IFSTA Pumping and Aerial Apparatus Driver/Operator 3rd edition to IFSTA Pumping and Aerial Apparatus Driver/Operator 4th edition.

SIGNIFICANT CHANGES

The following Driver/Operator courses will now include an accredited-level written exam and skills evaluation:

- Emergency Vehicle Driver Training
- Driver/Operator Pumper
- Driver/Operator Mobile Water Supply
- Driver/Operator Aerial

Upon completion of all skills, students will receive an accredited-level certificate.

This update renames the Driver/Operator courses as follows:

- Emergency Vehicle Driver Training: new course code 1270
 - Students who successfully complete this course will receive a state-issued certificate. To receive an accredited certificate, students must complete and submit an over-the-road skills evaluation after course completion. They may do this in one of two ways:
 - Submit a copy of their DMV Class E license.
 - Submit a completed and signed over-the-road skill evaluation sheet.
 - Students have 18 months from course completion to submit the required documentation. Submissions received after 18 months will not be eligible for an accredited certificate. Forms and directions will be included with the state certificate. All documentation must be emailed to <u>SCFA.Reciprocity@llr.sc.gov</u>.
 - Driver/Operator Pumper: new course code 1271
 - Increased from 40 to 48 hours and includes three new chapters and four new skills.
 - Driver/Operator Mobile Water Supply: new course code 1272
 - Driver/Operator Aerial: new course code 1275

The updated Driver/Operator courses will <u>not</u> require an accredited certificate as a prerequisite to move through the series. For example, if someone has the current EVDT (taken before the September 1, 2025 changeover), they can still take the updated Driver/Operator- Pumper course. Retaking EVDT is NOT required.

Students who completed these Driver/Operator courses prior to September 1, 2025, will be eligible to challenge the new accredited-level exam until February 1, 2027. For details on how to challenge exams, visit https://statefire.llr.sc.gov/scfa/retesting.aspx

INSTRUCTOR UPDATE REQUIRED

Active instructors *currently* certified to teach Emergency Vehicle Driver Training, Pump Operations 1, Pump Operations 2/MWS, and/or Aerial Operations must complete an instructor update before delivering any updated courses. The previous versions will no longer be offered. Instructors who do not complete the update must take the full Instructor Orientation Workshop (IOW) before they can resume teaching.

The self-paced updates will be delivered virtually through Blackboard. Instructions for accessing the updates will be emailed to students a few days prior to the start of class.

Upon completion, instructors will receive an access code to download the updated instructor materials.

<u>Note</u>: This update does not expand teaching certification. Instructors will remain certified only for the courses they were previously approved to deliver.
