



## **Curriculum Updates: Firefighter I/II & Auto Extrication**

As previously communicated (<u>click here to view</u>), **effective August 1, 2025**, the South Carolina Fire Academy will begin offering updated Firefighter I, Firefighter II, Auto Extrication, and the Modular Series programs. This update aligns course content with the 2024 edition of NFPA 1010. The curriculum will transition from IFSTA Essentials 7 to Essentials 8.

## **SIGNIFICANT CHANGES**

- Firefighter I and II will now use separate textbooks.
- Auto Extrication and the Modular Series (1101, 1102, 1103) will be updated to the 1010 standard.

## **INSTRUCTOR UPDATE REQUIRED**

Active instructors *currently* certified to teach Firefighter I, Firefighter II, and/or Auto Extrication must complete an instructor update before delivering any updated courses. The previous versions will no longer be offered. Instructors who do not complete the update must take the full Instructor Orientation Workshop before they can resume teaching.

The self-paced updates will be delivered virtually through Blackboard. Instructors will review course changes and electronically sign acknowledgment forms. Instructions for accessing the updates will be emailed to students a few days prior to the start of class.

Upon completion, instructors will receive an access code to download the updated instructor materials.

**Note:** This update does not expand teaching certification. Instructors will remain certified only for the courses they were previously approved to deliver.
